

Attorney General Opinion Issued on Construction Management-At-Risk Services

The Tennessee Attorney General has issued an opinion (Opinion No. 17-49) relating to construction management-at-risk services for the construction of local

correctional facility projects or additions to existing correctional facility buildings. According to the Attorney General, these construction manager-at-risk contracts are not permitted under T.C.A. § 12-4-107(b). Click the link below to read the opinion.

Opioid Crisis Resources


Litigation Against Opioid Manufacturers and Distributors

The University of Tennessee, or “UT” as it is known in Tennessee, traces its origins to Blount College, which was founded in Knoxville in 1794.

Blount College wasn’t like most colleges today. There were very few students. There were no sports teams. Like most colleges of that day, it taught the so-called “classics” – subjects like Latin, Greek, logic, and philosophy.

Blount College later became known as East Tennessee University. After the Civil War, Congress passed a law creating land grant colleges. East Tennessee University became the main land grant college of Tennessee. The college’s name was later changed to The University of Tennessee.

Rural Health Information Hub and Grant Opportunities

The Health Resources and Services Administration of the U.S. Department of Health and Human Services has created a website resource for rural health, [the Rural Health Information Hub \(RHIfhub\)](http://www.ruralhealthinfo.org/funding/4028).

Formerly the Rural Assistance Center, RHIfhub is funded by the Federal Office of Rural Health Policy to be a national clearinghouse on rural health issues. RHIfhub provides access to current and reliable resources and tools to plan,

develop, and implement solutions for addressing health-related issues facing rural communities.

As rural designation may not always be clear, the website also includes a tool, “[Am I Rural?](http://www.ruralhealthinfo.org/funding/4007)”, for determining whether an area is classified as rural.
