RE: Salary Increases Effective September 1, 1982

The General Assembly recently enacted the County Officials Salary Bill (SB2012/HB1949), subsequently designated Public Chapter 910, which will give those county officials whose salaries are determined by T.C.A. 8-24-102 (maximum salary law) and T.C.A. 8-24-104 (minimum salary law) an across the board seven percent (7%) salary increase effective September 1, 1982.

Enclosed you will find schedules of salary increases for salaries affected by this legislation. The tables show current annual salary, annual salary effective September 1982 and the fiscal year 1982-83 salary for budgetary purposes.

The county highway official's minimum salary cannot be less than the salary of the county clerk (T.C.A. 54-7-106).
