Record-Keeping Requirements Under Fair Labor Standards Act



The U.S. Department of Labor's Wage and Hour Division publishes a helpful fact sheet explaining the recordkeeping requirements for employees under the Fair Labor Standards Act (FLSA). Fact Sheet #21 lists 14 categories of records employers (and employees in some at keep and the period of time for which they must be kept. "Exempt" employees (executive,

instances) must keep and the period of time for which they must be kept. "Exempt" employees (executive, administrative, and professional) are exempt from some of these recordkeeping requirements, but not all of them. For exempt employees, employers are not required to maintain records for items 6 - 12 on the list in the fact sheet, but items 1 - 5 and items 13 and 14 must be maintained (see 29 C.F.R. part 516).

Tipton County is located in West TN bordering the Mississippi River on its western boundary. Over a period of about 24 hours in March of 1876, the Mississippi River abandoned its former channel that coincided with the TN-Arkansas border, and placed two communities (now referred to as islands), Reverie and Corona, on the Arkansas side of the river while most of the area of Tipton County is located on the east side. Now, access to this Tipton County land is only by boat or through Arkansas or Missouri.

Tipton County describes itself as the "sweetest County in the world" with industries including Charms/Tootsie Roll, making the famous "Blow Pops" and "Sugar Daddy" pops; Unilever, the leading ice cream manufacturer in North America, making Klondike bars, Ben & Jerry's, Bryer's, and Good Humor; and CSC Sugar, who provides non-GMO sugar to U.S. food processors.

The County is also home to the longest serving Speaker of the House of Representatives, Jimmy Naifeh, who served as Speaker from 1991-2009. The Naifeh family hosted the annual Coon Supper in Covington, which began in 1945. Other cities in Tipton County include Brighton, Munford, Atoka, and Mason.

Timekeeping Requirements Under the FLSA

As counties prepare for the new overtime regulations to take effect on December 1, questions may arise about timekeeping requirements for nonexempt (overtime eligible) employees under the Fair Labor Standards Act (FLSA). The FLSA does not specify a particular form of recordkeeping that employers must use. The law simply requires that the employer keep a record of the total hours worked each workday and the total hours worked each workweek for each nonexempt employee. Time clocks are not required. The employer is not required to record what time the employee starts or finishes, only the total number of hours worked each day. Employers may use any timekeeping method they choose, as long as the timekeeping plan is complete and accurate.



Some employers may be wondering, "If I reclassify an employee from exempt to nonexempt, what new timekeeping requirements apply to that employee?" Let's look at the options.

- 1. You may choose to use the same system you already have in place for recording time for your other nonexempt employees, or you may choose to use a different system for your newly reclassified employees that is more appropriate for the work they do.
- 2. If the employee works a fixed schedule from which they seldom vary, the employer may keep a record showing the exact schedule of daily and weekly hours and merely indicate that the worker did follow the schedule. If the worker's actual time varies from the schedule, the employer must record the number of hours the worker actually worked, on an exception basis.
- 3. Employees who work flexible hours may continue to do so. The employer may simply require the employee to provide the total number of hours worked each day, including any overtime hours.

To help ensure accuracy, it is a good idea to record an employee's time (or exceptions to the fixed schedule) on a daily basis and have the employee sign the record. Supervisors should also sign off on the time records and review them regularly for errors.

IRAN DIVESTMENT ACT – List of Ineligible Vendors

The Iran Divestment Act, 2016 Public Chapter 817, required the state's chief procurement officer (CPO) to publish and keep updated on its website a list of persons it determines engage in investment activities in Iran. Persons who appear on this list are ineligible to contract with the state or any political subdivision of the state. The state CPO has published <u>its list dated July 15, 2016</u>, which can be found on the Department of General Services' <u>Public Information Library page</u>.
