

Joint CTAS & CIS Program: Energy Audits for Counties

A program began in 2013 as a joint venture between the Center for Industrial Services (CIS) and County Technical Assistance Service (CTAS) for providing a lower-cost energy audit alternative. This audit program involves examination of the electrical, water/sewerage, and natural gas usage of a county building to identify possible areas in which the county could save money. CTAS and CIS are offering this program as an alternative to typically more expensive private energy audits.

Although many counties are very aware of their usage and budgetary needs, sometimes identifying small changes can result in big savings. One example is switching fluorescent light bulbs to LED. This energy audit program can assist the county in making that type of determination among others to open opportunities to save money.

To participate in this program, a county simply needs to make a request to their CTAS County Government Consultant. The request will be forwarded to CTAS and CIS to begin the assessment. The CIS consultant will request three years' worth of utility bills for the building being audtied to build the data needed to do the analyses. Typical data used

for these analyses include electrical cost and kilowatt hours, features and operational hours of lighting, and water usage. These data are averaged over a three-year period, which provides insight into future expected usage.

The assessment will result in two deliverables: 1) a report containing charts and graphs of the data analyzed; and 2) a report containing narrative describing the current energy usage for the building and recommendations for opportunities for cost savings.

County Spotlight Dyer County

Dyer County was created on October 16, 1823 by Private Act (Private Acts of 1823, Chapter 108). Section 7 of Chapter 108 stated that "the courts of Pleas and Quarter Sessions shall be held at the house of John Warrens, in said county." John Warrens was one of the settlers who made the third settlement in the area in the 1820s. He also built the second horse-drawn corn mill in the county, about 15 miles southeast of Dyersburg.

Today, Dyer County is home to the 2nd Amtrak stop in Tennessee in Newbern.

The General Assembly has amended the law relative to the appointment of utility district commissioners each of the past four years. The intent of these amendments was to streamline the appointment process, make the process more uniform throughout the state, and move away from utility districts appointing their own members towards either such members being appointed by the county mayor or by an election of the customers of the utility district.

The new procedure is outlined in T.C.A. § 7-82-307(a). Generally for single-county utility districts, it provides that if members are not selected in an election of the district's customers then when a member's term is about to end the district commissioners must submit a list of three potential replacements to the county mayor. The statute provides for a similar process for the appointment of district commissioners in multi-county utility districts.

The county mayor then either appoints someone from the list or rejects the entire list. If the mayor takes no action then the first name on the list is deemed appointed. The mayor's decision must be entered on the minutes of the county commission and a certified copy must be sent to the utility district commissioners and the appointee.

If the mayor rejects the entire list, then the mayor must send a letter to the district commissioners asking for a new list of names. The mayor may also reject the entire second list and send another letter to the district commissioners, but if the mayor rejects the entire third list then the county commission appoints the member from any of the previously submitted three lists.

The following is a more detailed summary which includes important time requirements:

- » Within sixty days after the occurrence of a vacancy, and no later than thirty days prior to the expiration of the term of office, the utility district board of commissioners shall select three nominees to fill such office, and shall certify such list of nominees in order of preference recommended by such commissioners, to the county mayor;
- » Within twenty-one days after the issuance of any certification by the board of commissioners to the county mayor, the county mayor may enter an order either appointing one of the nominees or rejecting the entire list or may refrain from taking any action, in which event the first name on the list of nominees shall be deemed appointed to fill the vacancy or new term by operation of law;
- » Any order either appointing or rejecting a list of nominees shall be entered of record on the minutes of the county legislative body and a certified copy of the order must be sent to the board of commissioners and to the appointee;
- » If the first or second list is rejected in its entirety, then within fourteen days following the entry of the order rejecting the entire list, the county mayor shall make a written request to the board of commissioners to submit an additional non-identical list of names; and
- » If the county mayor enters an order rejecting the third list, then the county legislative body shall appoint a commissioner from any of the three lists at the meeting of the county legislative body in which the mayor's order rejecting the third list of nominees is entered of record on the minutes of the county legislative body.
